Minutes of the Circle Relaxation Committee Meeting held on 27.06.2019 and 17.07.2019 to consider the cases for appointment to the dependents of deceased departmental officials under Compassionate Grounds in Relaxation of Recruitment Rules.

The Circle Relaxation Committee consisting of the following officers met on 27.06.2019 and 17.07.2019 and examined the claims for Compassionate Appointment received from the family members of the Deceased Departmental officials for appointment in Group – C cadre.

- i. Smt. B. Radhika Chakravarthy, PMG, Head Quarters Region – Chairperson
- ii. Smt. N.R. Visalatchy, DPS, Head Quarters Region. – Member
- iii. Sri V.V. Satyanarayana Reddy, DPS (HQ) , Telangana Circle – Member

2. The following is the vacancy position in different cadres in Group C which was arrived @ 5% of the total vacancies under DR Quota meant for Compassionate Appointment for the years as per Directorate orders on the subject and the CRC has considered the cases of Compassionate Appointments limited to the extent of vacancies earmarked.

3. The CRC has considered a total number of Fifty two (52) cases out of which 10 cases were received after the last CRC held on 16.04.2018 to 19.04.2018 and 42 cases relating to the previous CRC which were not recommended due to limited number of vacancies earmarked for compassionate appointments. The CRC made its recommendations by following instructions on the subject issued by the Postal Directorate from time to time.

4. The CRC has considered and recommended six (6) cases for Compassionate Appointment in the cadre of Group-C as indicated against each case taking into consideration of the allocation of points to the applicants based on various attributes indicated in the Directorate Lr. No. 37-36/2004- SPB-I/C dated 20.01.2010. The List of recommended candidates in respect of all cadres is enclosed as **Annexure – I**.

5. The following three (3) cases are recommended by the CRC subject to upper age relaxation by the Head of the Circle, as the applicants are over aged and Head of the Circle is competent to relax upper age limit. As per Recruitment rules, the upper age limit is 27years for PA/SA and 25 years for MTS in case of Direct Recruitment.




6. Forty Six (46) cases were considered and not recommended by the CRC, since the vacancies are restricted to 5% of the total DR vacancies as prescribed by Directorate and also on the ground that they did not merit the selection as per relative merit points prescribed by the Directorate. These cases are further recommended for placing before the next CRC for reconsideration. The List of cases not recommended by the CRC and recommended to place before the next CRC is enclosed as **Annexure-II**.

7. The following cases are considered by the CRC as per the orders of the Hon'ble CAT, Hyderabad.

- i. As per the Hon'ble CAT, Hyderabad order dated 15.11.2018 in OA No. 1258/2015 filed by Smt. Polepaka Tara, W/o Late L. Mallaiah, Ex-SPM, Peddapalli Division, the case of the applicant was considered and recommended by the CRC.
- ii. As per the Hon'ble CAT, Hyderabad order dated 01.03.2019 in OA No. 664/2016 filed by Smt. Mahaboob Pasha, W/o M.A. Azeez & Sri Md. Zaheeruddin, S/o M.A. Azeez, Ex-PA, Peddapalli Division, the compassionate appointment case of Sri Md. Zaheeruddin was considered by the CRC and the CRC has not recommended the case due to limited no. of vacancies and also on the ground that it did not merit the selection as per relative merit points. Further the CRC has recommended the case for reconsideration in the next Departmental CRC.

ii. As per the Hon'ble CAT, Hyderabad order dated 13.06.2019 in OA No. 271/2018 filed by Smt. Siva Kameswari, D/o V.I. Chary, Ex- PM, Suryapet Division, the compassionate appointment case of Smt. Siva Kameswari was considered by the CRC and the CRC has not recommended due to limited no. of vacancies and also on the ground that it did not merit the selection as per relative merit points. Further the CRC has recommended the case for reconsideration in the next Departmental CRC.






