The Limited Departmental Competitive Examination (LDCE) limited to GDSs (common examination) for the vacancy year 2018 (April-2018 to December-2018) and to MTS & GDS for the vacancy year 2019 (01.01.2019 to 31.12.2019) will be held on **29<sup>th</sup> of September, 2019 (Sunday)**. Accordingly, applications are invited from the willing and eligible candidates in the format enclosed (**Annexure-I**). The schedule of activities of the examination is furnished hereunder:

\* Exam will commence at 10:00 AM sharp and both the Paper-I & II will be conducted in continuity in one sitting from 1000 hrs to 1235 hrs. There will be 5 minute's break in between Paper-I and Paper-II, but, candidates cannot be allowed to leave his/her desk

2. **Vacancies:** . Number of vacancies to be filled up amongst eligible GDS for the year 2018 (i.e., 01.04.2018 to 31.12.2018) is furnished in **Annexure-A**.

Number of vacancies available in r/o year 2019 (01.01.2019 to 31.12.2019) is furnished in **Annexure-B**.

➤ The vacancies notified are likely to vary / change without any prior intimation.

**3. Eligibility Criteria:** - As per the Department of Posts Postman and Mail Guard (Group 'C' Post) Recruitment Rules, 2018 notified in GSR 899 (E) dated 20.09.2018, the following categories of official(s) are eligible to appear in the examination:

(i) Multitasking Staff (MTS) in Level -I of the pay matrix with three years regular service in the grade as on the 01.01.2019 for vacancy year 2019

(ii) Gramin Dak Sevaks (GDSs) who have worked regularly for five years in that capacity as on 01.04.2018 for vacancy year 2018 and 01.01.2019 for vacancy year 2019 fulfilling the following conditions:

(a) **Educational Qualification:** 10<sup>th</sup> standard pass from a recognized Board.

(b) **Age:** Age limit is furnished here under for vacancy year 2018 & 2019.

(c) The candidate should have studied local language at least upto 10<sup>th</sup> standard. (Local language is notified by SPN Division of the Directorate vide Annexure- E of letter No. 17-08/2018-SPB-I dated 10.05.2019, 28.06.2019 & 11.07.2019)

(d) Knowledge of working on Computer

(e) Candidate should have a valid license of two-wheeler or light motor vehicle. Persons with Disability are exempted from the possession of license. However, GDS without license to drive two wheeler or light motor vehicle shall also be allowed to appear in the examination.

**[This condition is required for recruitment to the cadre of Postman only ]**

**Note:-**

(i) Candidate belonging to postal division shall clearly indicate order of preference in Application form of postal divisions excluding parent division followed by RMS divisions.

(ii) Candidate belonging to RMS division shall clearly indicate order of preference in Application form for RMS divisions excluding parent division followed by Postal divisions.

(iii) Candidate should exercise preference for all Recruiting Units for consideration in the proforma at **Annexure-II**.

(iv) Order of preference (**as per Annexure-II**) once exercised shall not be changed.

**4. Pattern & Syllabus of Examination:** The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure -'B' read with letter No. 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019 & 23.07.2019. Details of Pattern and Syllabus are furnished in **Annexure-III**.

**Note:**

Paper-III i.e. 'Skill test of data entry' will be conducted subsequently.

- 5. Centres of Examination:** The Examination will be conducted at all Circle / Regional Headquarters only. The candidates shall have to appear from the respective centres of their Circle only and under no circumstances, they be permitted to appear from other Circle centres.
6. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle Office.
7. This notification may be given wide publicity amongst all GDSs working in all Divisions/Units.
8. The Divisional Heads / Controlling Authority are requested to intimate the number of applications received to the concerned Regional Office by 09.09.2019 and the Regional Offices are requested to send particulars of the candidates in the prescribed proforma (**Annexure-IV**) duly filled in *excel sheet* to the Circle Office through email id: [adrectt.tlg@gmail.com](mailto:adrectt.tlg@gmail.com) by 13.09.2019 for allotment of Hall Permit Numbers.
