PMG, Hyderabad Region / Head Quarters Region will issue necessary allotment orders to the divisions immediately to enable the Divisional heads to issue posting orders immediately and ensure that the officials join in the promotional posts immediately.

If an official is drawing his/her pay in Level-5, level-6 and level-7 of pay matrix of 7<sup>th</sup> CPC is not eligible for pay fixation under provision of FR 22(1)(a) (1). If the official is not drawing the pay in the levels of pay matrix referred to above may exercise his/her option for pay fixation under the provisions of FR 22(1)(A) (1) within one month from the date of assuming the charge in the promoted post.

If any Vig/Disc cases are pending against the promoted officials, he / she should not be relieved on his /her promotion and the same may be intimated to this office.

In case the official declines promotion, an unconditional declination letter may please be obtained immediately and to be forwarded to this office for its acceptance. If any official declines promotion, he/she should note that he / she is not eligible for promotion to the cadre of LSG for a period of 1 (one) year either on regular or adhoc basis from the date of declination. Further, the official who declines promotion will not be considered for financial upgradation under MACP Scheme, if any due, as per the existing rules / instructions till they accept promotion.

The official should accept/ decline the promotion unconditionally in writing within **one month** from the date of issuance of the posting orders. The date of joining of officials in the LSG Accountant (Postal) cadre may please be intimated.


